### Feedback from Students and Action Taken Report

## <u>2021-22</u>

The college collected feedback from the faculty members in May 2022 after distributing the feedback form. A total of seventeen faculty across the department returned feedback. All the feedback report has been discussed with Principal, IQAC and with faculty members. The characteristics of suggestions requested were related to academic and non-academic development of college and faculty.

### A total of ten suggestions were sought, which are as follows:
